AAC & Language Acquisition: A Therapist's Approach

- 1) Participants will identify at least three characteristics of complex communicators that may benefit from augmentative and alternative communication (AAC).
- 2) Participants will be able to state the difference between core and fringe vocabulary and be able to select which vocabulary to use for a specific activity.
- 3) Participants will explain the evidence-based practice of Aided Language Stimulation and how to implement this technique in a therapy setting.
